

The REL facilities in St Jean de la Rulle France were audited September 13 and 14, 2010 for compliance with the requirements of MIL-PRF-6106, MIL-PRF-83726 and MIL-STD-790. Based on this audit and acceptance of the corrective actions submitted, an acceptable level of confidence has been established that the compliance with the requirements has been successfully demonstrated; therefore, REL, A Company of STPI is considered a certified manufacturer eligible to manufacture electro-mechanical relay products.

A MIL-STD 790 certificate for your facility is enclosed with this letter. This certification is valid until withdrawn by the qualifying activity. If warranted, this certification may be withdrawn by this Center at any time.

During the certification period, your facility is subject to periodic reaudits. In addition, a drop-in audit in accordance with the requirements of MIL-STD-790 may be performed.
